## SUMMARY

On July 17, 2019, the District authorized the issuance of RFP No. 19.031, Contracted Transportation Services. The purpose of this Request for Proposal is to obtain qualified transportation companies to transport special needs students throughout the District. No school or department can spend more than is budgeted without prior approval from the Finance Department. This contract is also available to members of the Greater Phoenix Purchasing Consortium of School (GPPCS) and Strategic Alliance of Volume Expenditures (SAVE) cooperatives. In accordance with A.A.C. R7-2-1191 through R7-2-1195, Washington Elementary School District acted as the lead district for the cooperative agencies.

Twenty-nine (29) vendors were notified of the solicitation. Eleven (11) responsive, responsible offers were received and opened on August 8, 2019. James Spellman, Director of Transportation, Virginia Fish., Special ED Supervisor Transportation evaluated the proposals and recommend Com Trans, Apache Taxi, ALC Student Transportation Solutions, Catapult Learning, ACES and Reliable Transit Services. A multiple award is the most advantageous to ensure the best and most complete service availability for the District and Cooperative agencies.

The award of this solicitation will result in a one (1) year contract beginning upon award with the option to renew for four (4) additional years or portion thereof. The estimated requirements cover the period of the contracts and are reasonable and continuing. Included is a provision for cancellation by the District with thirty (30) days prior written notice. Copies of the solicitation and responses are available for review in the Purchasing Department.
